

## PRIVACY STATEMENT ON THE PROCESSING OF PERSONAL DATA- CONTACT FORM

As Borusan Makina ve Güç Sistemleri Sanayi ve Ticaret Anonim Şirketi (“**Company**” or “**Borusan CAT**”), the protection of your personal data we obtain while conducting our processes is one of our top priorities. We attach importance to ensuring the security of your personal data and its use/processing in accordance with the legislation.

We present this privacy statement to inform you about how we process your personal data when you contact our Company through the contact form on the [www.borusanecat.com](http://www.borusanecat.com) website.

### 1. Data Controller

Borusan CAT acts as the data controller in terms of processing your personal data.

### 2. Purposes and Legal Grounds of the Processing of Personal Data

Articles 5 and 6 of the [Personal Data Protection Law No. 6698](#) (“**the Law**”) regulate the legal grounds for the processing of personal data.

Within the scope of using the contact form, the purposes and legal reasons for the processing of your personal data are as follows:

If you have given your explicit consent, your identity and contact information will also be processed in line with your communication consent preferences to inform you about our advertisements, promotions, events, and campaigns.

### **3. Processed Personal Data**

Within the scope of the purposes specified in this statement, your identity, contact, transaction security and question, suggestion, request, and complaint information is processed.

### **4. Sharing Personal Data with Third Parties**

Your personal data is shared with suppliers, business partners, authorized institutions, and organizations to accomplish purposes stated in the heading of "**2. Purposes and Legal Grounds of the Processing of Personal Data**". While sharing your personal data with third parties, compliance with the rules of the Law regarding the transfer of personal data is ensured.

### **5. Methods and Legal Grounds of Personal Data Collection**

Your personal data is collected by partially automated methods through a form filled in electronically. Your personal data is processed based on the legal grounds specified under Article 5 of the Law of *the establishment, execution, or protection of a right, the fulfillment of legal obligations, the necessity of processing for our legitimate interests, and your explicit consent.*

### **6. Data Subject Rights**

Pursuant to article 11 of Law, you have right to learn whether or not your personal data have been processed and if your personal data have been processed, to request information about it, to learn the purpose of processing your personal data, and whether or not they have been used for the intended purposes, to know which third parties within Turkey or abroad your personal data have been transferred to, to request rectification if your personal data are processed incompletely or inaccurately, and to ask that the third parties to whom your data were transferred be notified of the amendments, to request deletion or destruction of your personal data in the case that the reasons for processing the data have disappeared even though they were duly processed according to The Law, and ask that the third parties to whom your data were transferred be notified of this change, to object to the processing, exclusively by automatic means, of your personal data, which leads to unfavorable consequences for you, to request compensation for any damages you incurred because of the unlawful processing of your personal data.
